# WWR Anti-Doping Education Requirements

As part World Wheelchair Rugby's Anti-Doping Education Program, all licensed wheelchair rugby personnel are required to complete anti-doping education. This includes athletes, coaches, and athletesupport personnel.

There are three options for completing this training:

- The World Anti-Doping Agency's ADEL online education platform
- World Rugby's Passport online learning hub
- Training provided by a National Anti-Doping Organization

This training needs to be completed before a participant will be licensed to participate in WWR international competitions.

# **Training Options**

**ADEL** 

Personnel using ADEL must complete the appropriate training for their role:

- Athletes: ADEL for International Athletes
- Coaches: ADEL for High Performance Coaches
- Support personnel: Athlete Support Personnel Guide to the Code 2021
- Medical personnel: ADEL for Medical Professionals at Major Games.

ADEL training can be accessed through the ADEL website:

Participants should register with ADEL and then search for the appropriate course from their learning dashboard.

#### **PASSPORT**

Personnel using World Rugby Passport training must complete the Keep Rugby Cleanonline training program.

This can be accessed through the Keep Rugby Clean website:

Select "E-Learning" from the menu bar to access the Passport site.

#### NADO

Personnel should contact their NADO training for details of the appropriate training tocomplete. Any training provided by a NADO must comply with WADA educational standards.

## **Major Games**

In addition to the above training, major events such as the Paralympic Games may have their own training requirements. These will be communicated to qualified members before each event where this applies.

## Confirmation

After completing the required training, participants should download the certificate orother confirmation that they have done so. This should be sent to their WWR member organization.

WWR member organizations are responsible to confirm through the WWR MALS that their licensed participants have completed the required training. See the attached instructions for how to complete this.

### **Training Confirmation**

The following steps are to be completed by WWR National Member Organizations to confirm that their licensed participants have completed the required anti-doping education:

- 1. Login to the MALS system.
- 2. Click on the *NMO Licensees* tab.
- 3. Identify the participant whose training you are confirming
- 4. Under the actions column (far right) click the *Upload Documents* button
- 5. Select the document type that you are uploading from the drop-down list
- 6. Complete the File Title and Description boxes
- 7. Select the file you are uploading this should be the appropriate certificate of completion for the training
- 8. Enter the **Expiry Date** of the certificate
- 9. Click Upload
